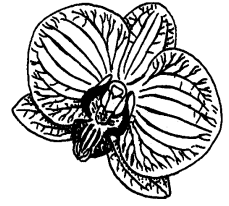

VENDING REQUIREMENTS: 1)

Fee: \$50.00 per table, include check with Exhibit Request Form and make check payable to Lincoln Orchid Society. Cancellations after October 20 refunded at \$25.00 per table, prior to date cancellation will be made in full.

Exhibit: display of 25 square feet minimum required, entry of display into competition is not required.

Donation: each vendor provide a plant or product of \$10.00 retail value for use in our raffles during the show.

Plant Sales:

Plant Labels: All sale plants must be properly labeled with appropriate name of orchid; numbered or generic labeling not permitted. Plants labels for specie plants must have Genus and Latin specie name, hybrids must have the Genus and Hybrid Name (Sanders Registry with the Royal Horticultural Society in the United Kingdom) or the Parents (Hybrids or species) listed on the label.

Plant Quality: All sale plants are required to be in good condition with no apparent diseases or pests.

Selective Sales: Be sure potential customers understand the culture requirements for these plants and if they have conditions necessary to grow them! This will benefit you by gaining future sales and buyers having plants that will flower each year, so they continue growing and buying plants.

Protection: Weather conditions may require wrapping or bagging of plants, provide at no additional cost.

Sales, Displays: Items in your display may be sold, but can not be remove by the buyer until the close of the show.

Restocking: NO restocking of sales tables will be allowed when show is open to public, Saturday 10:00 AM to 5:00 PM and Sunday Noon to 5:00 PM.

Scheduled restocking times: Saturday 5:00 - 6:00 PM and Sunday 10:30 AM - Noon.
